INSTRUCTIONS:

1. Township Ordinance requires that all dogs be licensed. All dogs 7 months or older must be licensed.

Exceptions:

- a) Newly acquired dogs must be licensed within ten (10) days of acquisition.
- b) Dogs must be licensed within ten (10) days of reaching licensing age.
- c) Dogs currently licensed in another state must be re-licensed in the Township within ninety (90) days.

2. All dog licenses expire on January 31 of each year.

3. License must be issued in the name of an adult member of the household.

4. No dogs are permitted to run at large. Owners will be subject to a fine.

5. There is no Township charge for licensing of Seeing Eye or Hearing Ear Dogs or service dogs for handicapped.

6. Check rabies information and neuter status. If there have been any changes since last registration, be sure to enclose required veterinarian certificates which will be returned. See license fee table.

7. **RETURN ALL COPIES** of this application, a self-addressed, stamped return envelope and a check payable to Township of Montgomery. Be sure to include rabies certificate (valid until October 31st of the licensing year) and spay/neuter certification where applicable. Renewal must be **POSTMARKED BY JANUARY 31** to avoid late fee. After validation, License will be returned by mail.

8. **WE DON'T SEND REMINDERS. SUMMONSES WILL BE ISSUED IN AUGUST FOR ALL UNLICENSED DOGS.**
